#### MINUTES OF MONTHLY BOARD MEETING

Also, in attendance was WCCD Director, Amanda O'Keefe and USDA-NRCS DC, Laura Galloway.

Dave appointed Dan to facilitate the meeting. Dan called the WCCD board meeting to order at 7:04 p.m.
