MINUTES OF MONTHLY BOARD MEETING & BUDGET HEARING

The Washakie County Conservation District (WCCD) held their monthly board meeting on Monday, July 16, 2018 at 7:00 p.m. in Ten Sleep at the Senior Citizens Center. WCCD Board members in attendance included; Vance Lungren, Charley Orchard, Dan Rice, and Susan Pennington. Also, in attendance was WCCD Director Victoria Dietz, and NRCS District Conservationist Laura Galloway.

Dan called the WCCD board meeting to order at 7:00 p.m.

Charley made a motion to approve the WCCD July 16, 2018 board meeting agenda. Vance seconded the motion. Motion carried.

The WCCD Board reviewed the June 18, 2018 board meeting minutes. Charley made a motion to approve the June 18, 2018 minutes as read. Vance seconded the motion. Motion carried.

FINANCIAL REPORT:

Tori reported the following financial account balances: WCCD main checking account; -\$22,007.89, Main Money Market account; \$124,208.17, Emergency Reserve Money Market account; \$76,372.06, Depreciation Reserve Savings account; \$1,005.57, and CD balance; \$16,738.85. EMPLOYEE REPORTS:

Tori provided the WCCD Board with her June Timesheet and reported on the following: Emergency Watershed Protection (EWP) Paxton Berm Update; NACD Technical Assistance Grant Update; Gooseberry Evaluation Day Report; Rural Cost Share Program Projects Completed (Otter Creek Grazing - PV Solar & South Flat Land & Livestock - Buried Pipeline); Big Horn River Level I Study Update; and Renew U Recycling Request for funding.

Tori requested that, for the next round of engineering designs under the NACD TA Grant, that Donell Fluckiger be considered for the design work. Dan asked what WCCD's procurement policy stated, regarding hiring for services. Tori read the WCCD's policy, stating that services hired under \$75,000 would need to be posted on the publicpurchase site for at least 10 days. Tori asked Laura Galloway for assistance in gathering up the information needed for the National Water Quality Initiative (NWQI) pivots that funds were recently obligated for.

Melanie Dedic's monthly report was provided to the WCCD Board previously via email.

Karen Fenton's monthly report was provided to the WCCD Board previously via email.

OLD BUSINESS

<u>WCCD Board Members Up for Re-Election Reminder</u> – Tori stated that Dan Rice, Charley Orchard, and Vance Lungren are up for re-election this year, and the filing date is between August 8th and August 27th.

Wyoming Public Land Initiative (WPLI) Comments – Tori provided the WCCD Board with information from Karen Fenton regarding the WPLI, a copy of the final comment letter Karen had developed on behalf of the WCCD Board, and a copy of the support letter from the Wyoming Association of Conservation Districts (WACD), for WCCD's comments. Discussion was held. Tori stated that she would forward the WCCD's WPLI comment letter to the Wyoming Department of Ag.

<u>WACD Awards Considerations</u> – Tori provided the WCCD Board with a list of award categories from WACD, to consider for any nominations. Discussions were held, but no nominees were decided upon.

FY 2019 Draft Budget Review - Budget Hearing - Dan called the WCCD Budget Hearing to order at 8:00 p.m. The WCCD Board reviewed and discussed the budget. No public was present. Charley made a motion to approve the WCCD's FY 2019 budget to include the following Reserve Account actions: Add \$1,000.00 to the Depreciation Reserve Account; Add \$15,000.00 to the Other Restricted Fund Reserve Account; Add \$7,105.00 and Deduct \$12,033.00 for "Planned to Spend" to the Emergency Reserve Account. Vance seconded the motion. Motion carried. The WCCD Budget Hearing was adjourned at 8:30 p.m.

NEW BUSINESS

<u>Big Horn Forest Steering Committee Field Trip</u> – Tori provided an email from the Big Horn Forest announcing the upcoming Big Horn Forest Steering Committee Field Trip on August 28th from 10:00 a.m. to 3:30 p.m., on the Tongue Ranger District. Tori stated that the agenda is not yet available.

<u>Executive Session - Outdoor Education Specialist Performance Review</u> – Susan made a motion to adjourn the regular WCCD Board meeting and go into Executive Session at 8:33 p.m. Charley seconded the motion. Motion carried. The WCCD Board discussed and reviewed the Performance Review conducted for Melanie Dedic, by Tori Dietz. The Executive Session was adjourned at 8:40 p.m.

The WCCD Board reconvened their regular WCCD Board meeting at 8:41 p.m. Charley made a motion to approve the performance review for Melanie Dedic. Vance seconded the motion. Motion carried.

Susan asked Tori what kind of response Melanie was getting for her upcoming Outdoor Classroom activities and suggested that if she wasn't filling her classes, that she might look into posting on the Community Garden Facebook Page, manning a table at the Washakie County Fair, and/or manning a table at the Farmers Market.
